

CITY OF BRAWLEY NOTICE AND INVITATION TO BIDDERS PURCHASE OF ROCK PRODUCTS, ASPHALT CEMENT CONCRETE

OTHER MISCELLANEOUS STREET PRODUCTS SPECIFICATION NO. 2025-02

NOTICE IS HEREBY GIVEN that sealed bids for Purchase of Rock Products, Asphalt Cement Concrete & Other Miscellaneous Street Products will be received by the City of Brawley (City) in the offices of Public Works, 180 South Western Avenue, Brawley, California 92227 until 2:00 P.M. Local Time, on March 5, 2025, at which time they will be publicly opened and read aloud. No late bids will be accepted.

The Contract for the work advertised will be awarded to the lowest responsible bidder. The city reserves the right to reject all bids, waive any irregularities, or dispense with further bidding.

<u>BID BOND</u>: Shall be completed in the forms provided as per Instructions to Bidders, <u>and</u> accompanied by a Certified Check, Cashier's Check, or a Bid Bond executed in favor of the City of Brawley in an amount of ten percent of the bid, to be forfeited as fixed and liquidated damages should bidder neglect or refuse to enter into a contract.

PROJECT DESCRIPTION: Bidder shall furnish and deliver rock products, asphalt cement concrete, and other miscellaneous street products upon request to the Public Works Department, 180 South Western Avenue, Brawley, CA 92227.

It is intended that the products be completed in every respect under the Contract, and such items or details not mentioned above that are required by the Contract documents shall be furnished, performed, placed, by the Contractor.

CONTRACT PERIOD: The contract period shall be for two years from the date of the Notice to Proceed. If mutually agreeable by both parties, the Contract may be extended for an additional twenty-four months on a month-to-month basis.

PRE-BID MEETING: A <u>Pre-Bid Meeting</u> will be held to familiarize all interested bidders with the conditions of the project. The meeting will convene at 10:00 a.m., at the <u>Public Works Office</u>, 180 South Western Avenue, Brawley, CA on <u>February 27</u>, 2025.

BIDDING DOCUMENTS: Bidding documents may be requested at 180 S. Western Avenue, Brawley, CA or via email at agutierrez@brawley-ca.gov or by calling (760) 587-4320 Monday through Friday from 8 am - 12 pm and 1 pm - 5 pm (closed from 12 pm - 1 pm). Bidding documents will be emailed to the bidder at the bidder's request; however, the City will not be responsible for delays.

Only those firms that have requested the bid documents from the City will be directly provided with any addendums that may be issued for this project before the bid opening date. If you requested from a plan room, it would be your responsibility to get your addenda updates from them, as we have no list of where you asked for anything other than the City.
