**NOTICE IS HEREBY GIVEN** that sealed bids for **Purchase of Chemical Products for Water Treatment Plant, Wastewater Treatment Plant and Parks & Recreation**, will be received by the City of Brawley (City) in the offices of Public Works Department, 180 South Western Avenue, Brawley, California 92227 until **2:00 P.M. Local Time, on May 7, 2025**, at which time they will be publicly opened and read aloud. No late bids will be accepted.

The Contract for the work advertised will be awarded to the lowest responsible bidder. The city reserves the right to reject all bids, waive any irregularities or dispense with further bidding.

**BID BOND:** Shall be completed in the forms provided as per Instructions to Bidders, **and** accompanied by a Certified Check, Cashier's Check or a Bid Bond executed in favor of the City of Brawley in an amount of ten percent of the bid, to be forfeited as fixed and liquidated damages should bidder neglect or refuse to enter into a contract.

**PROJECT DESCRIPTION:** Bidder shall furnish and deliver Liquid Chlorine, Copper Sulfate, Clarifloc C-308-P, Clarifloc WE-1474, Ferric Sulfate, Aluminum Chlorohydrate (ACH), Hydrochloric Acid (Muriatic Acid), and Sodium Bicarbonate.

**CONTRACT PERIOD:** The contract period shall be for two years from the date of the Notice to Proceed. If mutually aggregable by both parties, the contract may be extended for an additional twelve months on a month-to-month basis.

**PRE-BID MEETING:** A **Pre-Bid Meeting** will be held to familiarize all interested bidders with the conditions of the project. The meeting will convene at **10:00 a.m.**, at the **Department of Public Works, 180 South Western Avenue, Brawley, CA on April 23, 2025**.

**CONTRACT AWARD:** If a Contract is to be awarded, the City will give the successful Bidder or Bidders a Notice of Award. The successful Bidder or Bidders shall furnish to the City within 10 days of receipt of such notice the fully executed Contract Agreement.

**BIDDING DOCUMENTS:** Bidding documents may be requested from the City of Brawley Public Works Department via email at [vleon@brawley-ca.gov](mailto:vleon@brawley-ca.gov), Monday through Friday from 8 am – 12 pm and 1 pm – 5 pm (closed from 12 pm – 1 pm). Bidding documents will be emailed to the bidder at the bidder's request; however, the City will not be responsible for delays.

Only those firms who have obtained bid documents from the City will be directly provided Addendums that may be issued for this project prior to the bid opening date. If you requested bid documents from the plan rooms you will need to check with the plan rooms for a copy or follow up with the City to obtain a copy.
